

District Wide Parental Involvement Policy

In accordance with Elementary and Secondary Education Act (ESEA) the Beaver Creek School District agrees to implement the following statutory requirements:

PART I. GENERAL EXPECTATIONS

- Beaver Creek School will put into operation programs, activities, and procedures for the involvement of the parents at Beaver Creek School with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities, and procedures will be planned and operated with meaningful consultation with parents of participating children.
- Beaver Creek School will incorporate this parental involvement policy into its Local Education Agency (LEA) plan developed under section 1112 of the ESEA.
- Beaver Creek School will include, as a component, a school-parent compact consistent with 1118(d) of the ESEA, in which parents give permission for their child to participate in the Title One Program, and both parents and students sign to acknowledge their responsibilities while participating in the Title One Program.
- Beaver Creek School, in accordance with section 1111 of the ESEA, will provide full opportunities for the parents with limited English proficiency, parents with disabilities, and parents of migratory children, including providing information and school reports in an understandable and uniform format, and including alternative formats upon request, and to the extent practicable, in a language parents understand.

- Beaver Creek School will be governed by the following definition of parental involvement, and expects that Beaver Creek School will carry out programs, activities, and procedures in accordance with this definition:

Parental involvement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring-

(A) that parents play an integral role in assisting their child's learning;

(B) that parents are encouraged to be actively involved in their child's education at school;

(C) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;

(D) the carrying out of other activities, such as those described in section 1118 of the ESEA.

- Beaver Creek School will inform parents and parental organizations of the purpose and existence of the Parental Resource Center in the State of Arizona.
