# DEAR INTERESTED SUPPORTER OF BEAVER CREEK SCHOOL

Thank you for considering contributing to the success of public education in Arizona through the Arizona State Tax Credit Program. The generosity of individuals such as yourself allows us to enhance programs and offer greater opportunities to our students.

A tax credit is different from a deduction in that it is taken directly off your tax liability rather than being subtracted prior to the computation of your tax liability.

**A tax credit is only available to an individual...not a business. Please do not send company checks or cash. There are several ways to get this credit:**

-A married couple filing jointly is eligible for a maximum credit of \$400.

-Single individuals filing separate returns are eligible for a maximum of a \$200 tax credit.

-Those married, but filing separately, may have a combined total of \$250.

**To be eligible for a state tax credit in 2021, your contribution may be received or post-marked as late as April 15, 2022.** Remember you do not need to have a child enrolled in a school to take advantage of this credit.

Please call if you have any questions, or see your tax consultant for further information. In order to qualify for an Arizona Tax Credit, please complete the information to the right, together with your contribution.

Upon receipt of your payment and tax credit request, a receipt will be issued and mailed to you. Don't hesitate to call us if you need any further information regarding this matter. We look forward to hearing from you.
