- B. Specific Items of District Business which require Action
 - a. Approval of Revision #1 of the FY25 Budget. The FY25 Final Budget Forms have been made available. M/O budget is \$3,431,317.00 and the UNR is \$467,071.00 as presented. This is an increase of \$52,118 for M/O from the Adopted Budget on July 9, 2024. Tax rates were adjusted to the final amounts and there was no adjustment to the ADM used for budget calculations.
 - b. Request for approval of IGA with Grants management Services. This is a one year agreement (with an option to extend) to allow services between Beaver Creek Elementary District and Yavapai County through

- the Yavapai County School Superintendent. The contract has been reviewed by our attorney David Pauole.
- c. Request to discuss and approve the annual Capital Plan for the Division of School Facilities. The square footage formula by the state allows for 738 students on campus before additional funding from the SFOB would be obtained. The district is not growing therefore at this time the plan approval is a formality.
- d. Approval of revision of the Food Program Service Agreement
 Removal of Karin Ward, addition of Alexandra Wheeler, this contract
 needs to be changed to reflect new personnel. Mrs. Wheeler cannot be
 named in two spots on the form. We have asked that Lincoln Thomasson
 be approved as the "Authorized Official" and Mrs. Wheeler to be the
 "Designated Official." ADE requires a Governing Board Members name to
 be listed as the "Authorized Official."
- e. Request for approval of IXL Social curriculum. The supplemental Social Studies curriculum *IXL* has been on display at the school office and online since June 11, 2024, more than 60 days after the public meeting of the curriculum committee on May 17, 2024. The committee is requesting the curriculum be approved at the August board meeting so that it may be ordered and used as soon as possible. The Governing Board was given the notes from the curriculum committee meeting at the June 11, 2023 Governing Board meeting. Posting of the curriculum review links was on the website front page and a June 5th DOJO to families.
- f. First Reading of the following policies from The Trust Model Policies. The Policy Alert of July 2024, effective date of September 14, 2024. Second reading will happen on September 10, 2024. The Trust is proposing one new addition to policy and 5 new procedures and 10 policy changes, based on new legislation and Arizona Legislatures passing 331 bills.
