Proposed Policy Changes or Additions

- 1. No critical race theory.
- 2. No diversity, equity, and inclusion training.
- 3. No classes, flags, signs, or books that speak to alternative sexual behaviors.
- 4. No use of alternative pronouns, biological gender pronouns to be used.
- 5. No vaccination or masking will be provided or required without express approval of governing board.
- 6. No advertising or promotion of vaccines or masking of children on school grounds.
- 7. No financial assistance for teachers from school district to be trained in CRT, DEI or SEL, in whole or in part.
- 8. No presentations by "transgender" individuals on school grounds or to be promoted by the school or school employees.
- 9. Biological sex to determine use of men or women's bathrooms.
- 10. Only American, Arizonan and Cougar flags to be displayed on school grounds.
- 11. No notices of, signages for, or flags/banners to be displayed on school grounds for PRIDE events.
- 12. Sexual education to be limited to 8th grade, 1 class for 1 hour with talk about heterosexual behavior between one man and one woman.

Notes:

Sexual Activity, Sexual Identification, Suicides

A man cannot be a woman or a woman a man, EVER. No such thing as transition exists, it is masking a person's true identity to look and behave like a different sex. This is classified as gender dysphoria which is a psychological condition. Any child or adult that expresses disposition of gender dysphoria will be referred to a psychologist and parental notice will be given.

Over 46,000 suicides in the last year in the USA were due to despair and many of these were children. Over 35,000 members belong to an on-line transition group that are trying to retransition back to their biological gender. 53% of transitioned transgender males have attempted suicide following transition. 45% of LGBT youth have considered suicide.
